## **The Shadowing Experience**

The job shadow experience at Mile Bluff is meant to be an observational experience for high school or college students and non-college adults seeking information about jobs in the healthcare field. There will be no hands-on experience. Due to the discretion of patients or the staff person you are shadowing there may be limited access to some areas in a department. You will be assigned to a staff member preferably with the position in the department you are interested in. Some substitutions will be made depending on department availability. Please come prepared on the day of your shadow to ask any pertinent questions about the job so you meet all of your objectives for your job shadow.

#### Confidentiality/HIPAA

HIPAA (Health Insurance Portability Accountability Act): This federal law defines "protected health information" such as name, address, telephone number, date of birth, financial information and diagnosis/treatment of individuals you may come in contact with during your job shadow at Mile Bluff.

State and federal laws require all employees, volunteers and job shadow participants maintain a high level of confidentiality and privacy with respect to all medical or business nature concerning patients, providers or ancillary staff. **Under no circumstances are you to discuss such information with any unauthorized person(s) either inside or outside of Mile Bluff Medical Center.**

# Safety

Please report any unsafe conditions or injuries to the MBMC staff member you are working with or a supervisor in the department you are observing in. The following are emergency codes that may be announced during your time at Mile Bluff. Please follow the instructions of the person you are shadowing.

- Fire Alert: a fire has been detected in the facility
- Severe Weather Alert + Tornado Watch
  - Severe Weather Alert + Tornado Warning
  - Severe Weather Alert + Ice/Snow Advisory
- If other codes are paged follow the instructions of the person you are shadowing.

Please note that MBMC is a tobacco free facility and smoking is not allowed in/on any of MBMC's facilities or grounds.

### **Infection Prevention**

Hand washing is the single most important procedure in preventing the spread of infection in healthcare facilities. Some other actions that you can participate in to prevent the spread of illness include coughing into your sleeve, washing all surfaces of your hand for 15 seconds after blowing your nose or sneezing into a tissue; before eating and after using the restroom. To protect our residents/patients do not job shadow if you are not feeling well due to colds, flu or other illnesses. Please contact the HR Department at 608-847-1465 if you need to reschedule your job shadow.

### **Dress Code**

While job shadowing at MBMC you will be expected to follow our dress code guidelines to promote a professional image. All job shadows will be required to present a clean and neat appearance. Examples of appropriate dress include khakis, polo shirts, dress shirts, and dress pants. Inappropriate dress includes sweatshirts, leggings, tank tops and jeans. Shoes appropriate to the area you are job shadowing must be worn, and closed toe shoes must be worn in all areas at MBMC. Visible body piercings should be limited to the ears. Facial hair must be well groomed and trimmed.

### **Conduct and Behavior**

- All job shadow participants are required to abide by Mile Bluff's Standards and Values.
  These are enclosed.
- Participants should follow their designated staff member and listen to/follow their instructions at all times.
